Dear Residents of Monroe Manor,

The City of La Porte's Board of Public Works and Safety is improving infrastructure in the Monroe Manor Subdivision. The project will begin in August, completing the reconstruction of the neighborhood's infrastructure that began in 2015. This work will be managed in phases and extend through summer 2022. Glenview and Parkview Avenues are planned to be complete in 2021 with Lawndale, Eastwood and Silverbrook Avenues complete in early 2022. This \$3.15 million phase is funded out of the sewer and stormwater line items on your water bill.

- Tree removal is scheduled to begin the week of 7/26.
- The project includes new storm sewer, sanitary sewer, water main, curb, gutter, driveway approach, sidewalks and asphalt.
- New sidewalks will be installed throughout the project area, including areas where sidewalks do not currently exist.
- New water and sewer services will be extended up to the property line, which is generally the house side of the sidewalk. A cleanout will be installed between the sidewalk and curb.
- The contractor (HRP Construction) will coordinate with the post office and trash pickup (RTS) to insure service during the project.
- Access to driveways will be maintained. There will be short periods when excavation or equipment will block driveways.
