#### Minutes

#### Standing Committee Reports

Mayor's Veterans Committee: Councilman Galloway reported the Veterans Day Program held at the La Porte Civic Auditorium went well and was very well attended. The next Mayor's Veterans Committee meeting will be held March 13, 2023.

Business Improvement District: Councilwoman Cutler reported the Business Improvement District met Monday, November 14, 2022, at 5:00 P.M. at City Hall. At the meeting Director of Community Development and Planning, Craig Philips and Joel Baldin of Hitchcock Design Group presented an update on Monroe Landing and future Downtown streetscaping plans.
