## Redevelopment Commission Regular Meeting Minutes Wednesday, May 25, 2022 5:15 PM

A meeting of the City of La Porte Redevelopment Commission ("Commission"), was held at City Hall on Wednesday, May 25, 2022 at the hour of 5:15 PM, ("local time"), pursuant to notice duly given in accordance with the rules of the Commission and the Indiana Open Door Law.
