The Common Council of the City of La Porte met in regular session Monday, October 2, 2023, at 6:00 P.M. in Council Chambers.

Pledge of Allegiance

Councilwoman Feikes led the Pledge of Allegiance.

Roll Call: All Present

Approval of Minutes

Mayor Dermody stated each member received an advance copy of the minutes from the previous meeting and asked if there were any corrections or additions. Councilwoman Feikes moved to approve the minutes as presented, motion was seconded by Councilwoman West and unanimously approved.

Petitions and Comments of Citizens

There were no petitions or comments.

Standing Committee Reports

Sustainability Commission: Councilman Franke reported the Sustainability Commission met Monday, September 25, 2023, at 4:00 P.M. at City Hall in Council Chambers. Mr. Franke applauded Tucker King for securing a one million dollar grant to be used for trees. The Sustainability Commission discussed the stipulations laid out by the grant and what they might want to use the funds for.

Redevelopment Commission: Councilman Franke reported the Redevelopment Commission met Wednesday, September 27, 2023, at 5:15 P.M. at City Hall in Council Chambers. Claims were paid and a lease was discussed along with a Resolution that is being presented to the Council regarding property in the Thomas Rose Industrial Park.

Traffic Commission: Councilwoman Feikes reported the Traffic Commission will meet on Wednesday October 3, 2023, at 5:00 P.M. at the Police Station

Mayor's Veterans Committee: Councilman Galloway reported the Mayor's Veterans Committee will meet Monday, October 9, 2023, at the Park Department.

Police Merit Commission: Councilman Galloway reported the Police Merit Commission will meet October 10, 2023, at the Police Station. Lastly,

Councilman Galloway reported Bolt for the Heart will be on October 14, 2023, beginning at Cummings Lodge.

Traffic Commission: Councilwoman Feikes reported Traffic Commission will meet Tuesday, October 3, 2023, at 5:00 P.M. at the Police Station.

Business Improvement District: Councilwoman Cutler reported at the Business Improvement District meeting, City Planner Craig Phillips reported on the status of the irrigation system repairs for the downtown planters. A new control box was installed, and board member Liz Ward met with Craig to review the programing of the system. All planters had to be watered manually this summer by Mofield properties. Now that the Control Module is working, the City Planning Office will turn it on at the end of the season to make a list of all individual planters needing irrigation repair. The next Business Improvement District meeting will be Tuesday, October 10, 2023, at 5:00 P.M. at City Hall.

Urban Enterprise Association: Councilwoman Cutler reported at the Urban Enterprise Association meeting, Code Enforcement Director Jeff Batchelor requested and additional \$20,000 in grant funding for the Residential Dumpster Program, and it was approved. The Board discussed the possibility of an alley clean-up project for next Spring, and it will be considered at the November planning meeting. Business grant applications for exterior wall repairs at Bennetts Uptown Shoppes and parking lot improvements at Developmental Alliance were reviewed by the board and approved. A grant to cover the cost of repairs and re-coating of a UV sealant on the Mural at Plaza 618 was discussed and approved, as well as a Community Enhancement Grant for the Plaza Christmas Tree this year. The next Urban Enterprise Association meeting will be Wednesday October 18, 2023, at City Hall.

Fire Merit Commission: Councilwoman West reported the Fire Merit Commission will meet Wednesday October 3, 2023, at 6:30 P.M.

City of La Porte Police Officer Recognition

Mayor Dermody invited Chief Brettin to recognize Police Officers involved in saving a young person's life. Chief Brettin stated on August 28, 2023, officers responded to the area of the overpass for a juvenile female attempting to jump off the bridge. Officer Atkinson and Officer Helmecy both arrived on scene and jumped into action by grabbing and holding the juvenile until other officers and the fire department arrived to assist. Both Officer Atkinson and Officer Helmecy's actions directly impacted the outcome of this incident and for that they were awarded the Life Saving Award. Cpl. Adam Jaskowiak and Sgt. Justin Dyer also arrived on scene and helped in

holding the female up to prevent her from falling. For their actions, they were awarded the Commendation Award.

Mayor Dermody thanked the Officers, and everyone involved for saving this young person's life.
