Bert Cook, Executive Director of the La Porte Economic Advancement Partnership, stated this is a proactive measure as this is the type of development that has become more popular and as such, it is warranted to amend the Ordinance now in order to be ready for this type of development in the future. Mr. Cook noted this will clean up our Ordinance and gives us a chance to better reflect what is going on the Economic Development world and how our zoning ordinance interacts with that.

Mayor Dermody stated this Ordinance will move to the November 8, 2023 Council Meeting for consideration.
