Staff Presentation

Miles Fettinger called for staff to explain the request.

David Heinold, City Planning, explained that the City of La Porte is requesting to add Data Storage Facility to the list of permitted uses in the M1 and M2 Zoning Districts under the Utilities category and add a definition for

Data Storage Facility as a text amendment to the 2017 City of La Porte Revised Joint Zoning Ordinance. David explained the proposed zoning text amendment in more detail for types of uses that are included in the definition of Data Storage Facility. David mentioned that the zoning text amendment was advertised in the Herald Dispatch on September 27, 2023 in accordance with the legal notification requirements for this request.

Craig Phillips, CDP Director, explained that the City is requesting this zoning text amendment to allow Data Storage Facilities as a permitted land use in the M1 and M2 Zoning Districts to allow possible future developments for similar uses in the City of La Porte.

Miles Fettinger opened the meeting to public comment and called for public comments either for or against the zoning text amendment petition.

There being no further public comment, Miles Fettinger closed the floor to public comment.
