RESOLUTION NO. 1-2023

RESOLUTION OF THE CITY OF LAPORTE PLAN COMMISSION APPROVING AN AMENDMENT TO A DECLARATORY RESOLUTION APPROVED AND ADOPTED BY THE CITY OF LAPORTE REDEVELOPMENT COMMISSION

WHEREAS, the City of LaPorte Plan Commission (the "Plan Commission") is the body charged with the duty of developing a general plan of development for the City of LaPorte, Indiana (the "City"); and

WHEREAS, the City of LaPorte Redevelopment Commission (the "Redevelopment Commission") previously adopted and amended a Declaratory Resolution (the "Declaratory Resolution") establishing the Thomas Rose Industrial Park Economic Development Area (the "Economic Development Area") and the Thomas Rose Industrial Park Allocation Area in the City, and approving an Economic Development Plan for the Economic Development Area (the "Plan"); and

WHEREAS, on February 22, 2023, the Redevelopment Commission approved and adopted a Resolution (the "2023 Resolution") amending the Declaratory Resolution to add a certain project consisting of the acquisition of a leasehold interest in certain property as described in the 2023 Resolution; and

WHEREAS, the Redevelopment Commission has submitted the 2023 Resolution to the Plan Commission for its approval pursuant to IC 36-7-14-16;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF LAPORTE PLAN COMMISSION, as follows:

- 1. The 2023 Resolution and the amendment to the Plan contained therein conform to the plan of development for the City.
- 2. This Plan Commission hereby approves the 2023 Resolution and the amendment to the Plan contained therein. This resolution hereby constitutes the written order of the Plan Commission approving the 2023 Resolution and the amendment to the Plan contained therein pursuant to IC 36-7-14-16.
- 3. The Secretary of this Plan Commission is hereby directed to file a copy of the 2023 Resolution with the minutes of this meeting.
